# Funding Updates

- RFP for K-12 funding (roughly 30,000 grants) is closed. Funding requests have been sent for Governor's approval. Districts should be notified of awards and able to draw down in the next couple of weeks.
- <u>EC tuition credits</u> that reported the first week of September are in the process of being ISAd to higher ed partners. They are receiving \$135 per credit reported. We are still planning to reconcile enrollments in late fall and will make any needed adjustments up or down to spring tuition credits.
- DHE has another RFP out for dual enrollment. It is not meant for Early College Credits that were either reported the first week of September or will be reconciled in the late Fall count.

- **SIMS Reporting** record all students who have signed an early college application as 02 which refers to Early College. It identifies the type of High-Quality Career Pathway in which a student is enrolled.

# SCS Reporting

- report all EC course levels as postsecondary (04) "A course often taken at, or in conjunction with, a
  postsecondary institution, which contains instruction equivalent to a college-level course and for which
  a student may earn college credits."
- please use the course location code of your higher ed partner, even when courses are remote. It helps
  us confirm these are EC students and, in the case where there are two college programs in a high
  schools, it helps us identify which program each student is in.d


