
Guiding Principles

- 5: Fully implemented and meeting Criteria



Guiding Principles (continued)

Three questions, where you will need to provide additional information for a 1, 2, or 3 choice, also asks you to provide additional information if you choose a 4 or 5.

- Did you offer differentiated and enhanced academic and non-academic supports?
- Did your program track enhanced student support participation?
- Did your program provide career education and activities for Early College participants?


